

**THE COUNTY OF PEMBROKE (WATERY LANE, PEMBROKE)
(TEMPORARY PROHIBITION OF VEHICULAR TRAFFIC) ORDER 2018**

NOTICE is hereby given that Pembrokeshire County Council intend, not less than seven days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991.

The proposed Order is necessary so that electricity cabling works can be carried out.

The effect of the Order will be to temporarily prohibit all vehicular traffic other than exempted vehicles from proceeding along that section of Watery Lane, Pembroke, from its junction with Lower Lamphey road, south east to the end of the public highway near the property known as Upper Longstone.

Watery Lane is a no through road serving a number of properties. Access will be maintained to properties where practicable, subject to long delays.

Pedestrian access will be maintained for the duration of the closure.

It is intended that the restrictions, which will be signed accordingly, will come into effect on Tuesday 26th July 2018 and remain in force for approximately 15 days or until completion of the works.

The Order will remain valid for a maximum period of 12 months as a contingency should the works need to be rescheduled or in the event of any unforeseen circumstances.

RHODDIR rhybudd drwy hyn fod Cyngor Sir Penfro'n bwriadu gwneud Gorchymyn, nid llai na saith niwrnod o ddyddiad y Rhybudd hwn, dan Adran 14 Deddf Rheoleiddio Traffig Ffyrdd 1984 fel y diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991.

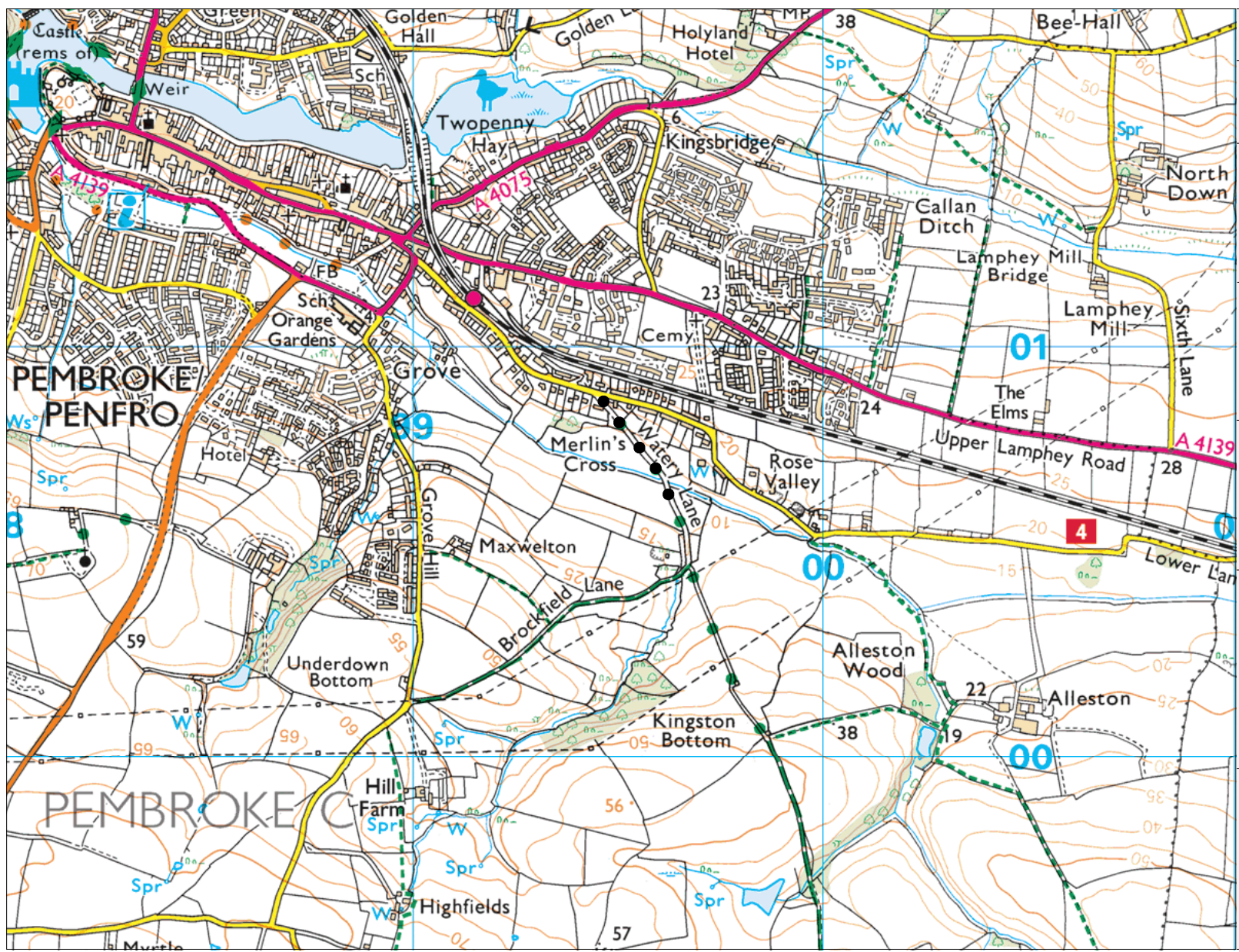
Bydd mynediad i gerddwyr yn cael ei gynnal tra bydd y ffordd ar gau.
